***Product Description:*** SUPPRESSOR ORG60 (FC3022)

**Allergen Status:** Product does not contain any of the allergens identified by the Food Allergen Labeling and Consumer Protection Act of 2004 including milk products, eggs, soybeans, tree nuts, peanuts, wheat, fish and crustacean shellfish. Furthermore, the product does not contain any of the identified allergenic materials including gluten, mustard, sesame seeds, sulfur dioxide and sulfites, lupin, mollusks or celery.

Product manufactured from highly refined Soybean Oil. The refining process is known to remove protein compounds. Products manufactured from highly refined oils are exempt from requirements of the Food Allergen Labeling and Consumer Protection Act of 2004.

**Gluten:** Gluten from wheat or other cereal grains are not an intentional component of this product.

**Genetically-Modified Organisms (GMO) Status:** Product manufactured from commodities that have been commercially grown GMO varieties in the supply chain, BUT do not contain GMOs because they have been sources from traditional crops under an identity preserved program that is documented by the supplier.

**Bioengineered Food (BE) Status:** This product contains highly refined oils that may be derived from genetically-modified crop sources. However, no genetically modified protein or DNA is known or expected to be present in product.

According to the National Bioengineered Food Disclosure Standard Final Rule 7 CFR 66, BE labeling is voluntary due to it does not contain detectable modified genetic material.

**Animal Derived Material:** No material of animal origin is used in the manufacture of this product.

**Kosher Status:** Certified Kosher – Pareve.

**Shelf Life:** Hydrite has not performed stability data on this product, however, based on the chemistry, we expect it to have a shelf life of at least 1 year, if stored in a tightly closed container at ambient temperatures, and mixed before use.
